

2000 CENSUS RESULTS FOR THE MARTINDALE-BRIGHTWOOD COMMUNITY

- The service boundaries, or “catchment” area, the CDC covers is bound on the: west by the Monon Trail, north by 30th Street, east by Sherman Drive and south by Interstate 70.
- Within the 46218 zip code boundary, there are several census tracts: 3517, 3519, 3521 and 3528.
- 93% of all community residents are of African-American descent.
- Over 35% of community residents are designated as being “low income.”
- The Martindale-Brightwood area median income is approximately \$25,000 annually.
- 34% of all neighborhood Head of Households are single females.
- 27% of single-female households have at least one child under the age of 18 living in their respective homes.
- The community supports approximately 100 religious institutions, of various denominations.
- Total population is 9,334.
